SUBJECT: ISSUE OF CNIC DIGIT/ ADDRESS OUT OF PROVINCE.

Reference: No. SO (G-I) SE&LD/S. Committee/2022 dated: 25-5-2022.

In continuation of the letters referred to the subject captioned above and to inform you that, the following candidates were appeared before the "Scrutiny Committee", constituted to determine the eligibility of their appointment as PST/JEST. The candidates who had any issue with the permanent address/digit of their CNIC# have produced the Domicile/PRC form-D, issued by the concerned Deputy Commissioner, along with their original documents with regard to the claimed status.

In the above context, the Law & Regulation wing of SGA&CD opined that, "*Law department is of the view that Administrative department should enquire from the concerned District Administration as to how PRCs/ Domiciles of Sindh were issued to the concerned persons against the CNIC having permanent address of other province.*" The Regulation wing of the SGA&CD, further advised to approach divisional commissioners, to probe into the matter, as to why such Domiciles and PRCs were issued to the incumbent(s), who were actually the permanent resident(s) of other province(s)?

As per advice the credentials i.e Domicile & PRC Form D, have been got verified from the Divisional Commissioners concerned and they had verified and marked as Genuine, hence the "*Scrutiny Committee*" has found that the following candidates are eligible for consideration of their appointment as PST / JEST, provided that if they had applied with the claimed status and fulfil other mandatory terms and conditions for recruitment as per policy:
